Corrigendum to Direction No. 10 of 2017 (regarding leading to the Degree of  
वाङ्मय पारंगत (Master of Arts) (Two Years – Four Semesters Degree Course)  
(Credit & Grade System).

Whereas, Direction Nos. 10 of 2017 Dt. 27.6.2017, 29 of 2017 Dt.20.7.2017 & 19 of 2018 Dt. 6.3.2018 regarding Semester and Credit Grade System for Degree of Master of Arts in the Faculties of Humanities and Inter-disciplinary Studies are in existence in the University,

AND

Whereas, the Ad-hoc Committee in Philosophy in its meeting held on 12.7.2018 vide item No. 7 has resolved to recommend the change in the eligibility criteria for admission to M.A. Semester-I (Philosophy).

AND

Whereas, Hon'ble Vice Chancellor had accepted the above eligibility criteria as graduate of any discipline of Statutory University for admission to M.A. Semester-I (Philosophy) under Sub-section (7) of Section 12 of Maharashtra Public Universities Act, 2016 on 7.8.2018,

AND

Whereas, it is necessary to carry out the corrections / changes to the above Direction immediately as the matter is to be implemented from the Academic Session 2018-2019 for Admission of M.A. Semester-I in respective Colleges.

AND

Whereas, the above changes are to be regulated by framing the Ordinance / Regulation,

AND

Whereas, making of Ordinance / Regulation is time consuming process.

Now, therefore I Dr. Murlidhar G. Chandekar, Vice Chancellor, Sant Gadge Baba Amravati University, Amravati in exercise of powers conferred upon me under Sub-section (8) of Section 12 of the Maharashtra Public Universities Act, 2016 do hereby direct as under :-

1. This Direction may be called, "Corrigendum to Direction No. 10/2017 regarding Examinations leading to the Degree of वाङ्मय पारंगत (Master of Arts) (Two Years – Four Semesters Degree Course) (Credit & Grade System) Direction, 2018".
2. This Direction shall come into force from the Academic Session 2018-2019.
3. The persons holding the bachelor degree of any discipline of a Statutory University (not less than three academic years programme) shall be eligible for admission to M.A. Semester-I (Philosophy).

In response to above amended eligibility criteria, "c) M.A. in Philosophy" be added after b) M.A. in Dr. Babasaheb Ambedkar Thought appears under iii) of sub-para B) of Para 7) of Direction No. 10 of 2017.
